7 **HOUSE RESOLUTION**

8 TO ENCOURAGE THE UNITED STATES CONGRESS AND THE  
9 ARKANSAS CONGRESSIONAL DELEGATION TO WORK TO END  
10 ORGAN HARVESTING FROM PRISONERS OF CONSCIENCE IN THE  
11 PEOPLE'S REPUBLIC OF CHINA.

15 TO ENCOURAGE THE UNITED STATES CONGRESS  
16 AND THE ARKANSAS CONGRESSIONAL DELEGATION  
17 TO WORK TO END ORGAN HARVESTING FROM  
18 PRISONERS OF CONSCIENCE IN THE PEOPLE'S  
19 REPUBLIC OF CHINA.  
20  
21

22 WHEREAS, extensive and credible reports have revealed mass killing of  
23 prisoners of conscience in the People's Republic of China, primarily  
24 practitioners of the Chinese spiritual practice of Falun Gong, but also other  
25 religious and ethnic minority groups, in order to obtain organs for  
26 transplants; and  
27

28 WHEREAS, the organ transplantation system in China does not comply with  
29 the World Health Organization's Guiding Principles On Human Organ  
30 Transplantation regarding traceability and transparency in organ procurement  
31 pathways, and the government of the People's Republic of China has resisted  
32 independent scrutiny of the system; and  
33

34 WHEREAS, traditional Chinese custom requires bodies to be preserved  
35 intact after death, which results in rare voluntary organ donation, but  
36 China's transplantation industry has increased significantly since 2000; and

2 WHEREAS, the 2017 Freedom House report, "The Battle for China's  
3 Spirit", states that "available evidence suggests that forced extraction of  
4 organs from Falun Gong detainees for sale in transplant operations has  
5 occurred on a large scale and may be continuing"; and  
6

7 WHEREAS, an investigative report published in June 2016 by human rights  
8 attorney David Matas, former Canadian Secretary of State for Asia-Pacific,  
9 David Kilgour, and journalist Ethan Gutmann, estimated that China is  
10 performing sixty thousand to one hundred thousand (60,000-100,000)  
11 transplants per year, as opposed to the ten thousand (10,000) transplants  
12 which had been projected by the Chinese government for 2015, amounting to "an  
13 industrial-scale, state-directed organ transplantation system, controlled  
14 through national policies and funding, and implicating both the military and  
15 civilian healthcare systems", as Kilgour described these practices in his  
16 speech to the European Parliament in 2016; and  
17

18 WHEREAS, according to the China Organ Harvest Research Center, China's  
19 Liver Transplant Registry System indicated that more than twenty-five percent  
20 (25%) of liver transplant cases were emergency transplants for which an organ  
21 was found within days or even hours, and that wait time for nonemergency  
22 liver transplants were usually quoted in weeks; and  
23

24 WHEREAS, most patients in other countries have to wait years for a  
25 transplant; and  
26

27 WHEREAS, the Chinese government claims that ninety percent (90%) of  
28 China's organ transplant sources come from executed prisoners, but the number  
29 of executions has dropped ten percent (10%) annually since 2002 and is far  
30 less than the number of transplants taking place; and  
31

32 WHEREAS, the Chinese government has never acknowledged the sourcing of  
33 organs from prisoners of conscience; and  
34

35 WHEREAS, Falun Gong, a spiritual practice involving meditative "qigong"  
36 exercises and centered on the values of truthfulness, compassion, and

1 forbearance, became immensely popular in China in the late 1990s with  
2 multiple estimates placing the number of practitioners at upwards of seventy  
3 million (70,000,000); and  
4

5 WHEREAS, in July 1999, the Chinese Communist Party launched an  
6 intensive, nationwide persecution designed to eradicate the spiritual  
7 practice of Falun Gong, including physical and mental torture, reflecting the  
8 party's long-standing intolerance of large independent civil society groups;  
9 and  
10

11 WHEREAS, since 1999, hundreds of thousands of Falun Gong practitioners  
12 have been detained extralegally in Chinese reeducation-through-labor camps,  
13 detention centers, and prisons, where torture, abuse, and unnecessary medical  
14 exams and blood tests on Falun Gong practitioners are routine; and  
15

16 WHEREAS, the 2017 Freedom House report states that in 2015, Falun Gong  
17 practitioners comprised the largest portion of prisoners of conscience in  
18 China and faced an elevated risk of dying or being killed in custody; and  
19

20 WHEREAS, the United Nations Committee Against Torture and the United  
21 Nations Commission on Human Rights Special Rapporteur on Torture have  
22 expressed concern over the allegations of organ harvesting from Falun Gong  
23 prisoners, and have called on the government of the People's Republic of  
24 China to increase accountability and transparency in the organ transplant  
25 system and punish those responsible for abuses; and  
26

27 WHEREAS, in June 2016, the United States House of Representatives  
28 unanimously passed House Resolution 343, condemning the systemic, state-  
29 sanctioned organ harvesting from practitioners of Falun Gong and other  
30 prisoners of conscience; and  
31

32 WHEREAS, the killing of religious or political prisoners for the  
33 purpose of selling their organs for transplant is an egregious and  
34 intolerable violation of the fundamental right to live; and  
35

36 WHEREAS, organ tourism to China should not be shielded by medical

1 confidentiality, but openly monitored; and

2  
3 WHEREAS, no nation should allow its citizens to go to China for organs  
4 until China has allowed a full investigation into organ harvesting of  
5 prisoners of conscience, both past and present,

6  
7 NOW THEREFORE,

8 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE NINETY-SECOND GENERAL  
9 ASSEMBLY OF THE STATE OF ARKANSAS:

10  
11 THAT the Unites States Congress and the Arkansas congressional  
12 delegation:

13 (1) Call upon the government of the People's Republic of China  
14 to:

15 (A) Immediately end the practice of organ harvesting from  
16 all prisoners and prisoners of conscience, including from Falun Gong  
17 prisoners of conscience and members of other religious and ethnic minority  
18 groups; and

19 (B) Immediately end the ongoing persecution of Falun Gong  
20 and release all Falun Gong practitioners and other prisoners of conscience;  
21 and

22 (2) Support a full and transparent investigation by the United  
23 States Department of State into organ transplant practices in the People's  
24 Republic of China and call for the prosecution of those found to have engaged  
25 in such unethical practices.

26  
27 BE IT FURTHER RESOLVED THAT the State of Arkansas:

28 (1) Encourage the medical community of Arkansas to engage in  
29 educating colleagues and residents of Arkansas about the risks of travel to  
30 China for organ transplants to help prevent Arkansas residents from  
31 unwittingly becoming involved in murder in the form of forced organ  
32 harvesting from prisoners of conscience; and

33 (2) Agree to take measures to ban the entry of those who have  
34 participated in illegal removal of human tissues and organs and seek  
35 prosecution of such individuals should they be found in Arkansas.

1 BE IT FURTHER RESOLVED THAT the Chief Clerk of the House of Representatives  
2 provide copies of this resolution to the Speaker of the House of  
3 Representatives of the United States, the Chair of the United States  
4 Committee on Foreign Relations, the Chair of the United States House  
5 Committee on Foreign Affairs, and all members of the Arkansas congressional  
6 delegation with the request that this resolution be officially entered into  
7 the Congressional Record.
